

## **House Rules and Regulations of District 5**

*Havlíčkova 292/1, 500 02 Hradec Králové*

1. By entering the premises, visitors agree to abide by the individual points of the rules of conduct. These rules of conduct determine the principles of behavior for all visitors to the bar, as well as their rights and obligations. Violation of these rules and regulations is grounds for punishment in accordance with the rules and regulations or for refusal of entry.
2. Visitors are defined as individuals or groups of individuals or institutions and their members and guests present on the premises. In the event of use of the premises outside of operating hours, the event organizer is responsible for all visitors.
3. The operating area of the bar (premises) intended for visitors consists of: the main entrance, hallway, lounge, main hall with a bar. Men's and women's toilets may only be used by customers, i.e. visitors who order goods or services and thereby undertake to pay for them.
4. The operator is responsible for the operation of the establishment and has the right to monitor compliance with the operating rules set out in these regulations and to take appropriate measures. These operating rules are binding on all visitors or institutions and their members or guests who use the premises.
5. Rights and obligations that are not expressly regulated and specified in these operating rules are governed by other internal regulations of the operator and the relevant provisions of applicable legal regulations, in particular legal regulations governing safety and health protection.
6. The operator reserves the right to expel a visitor from the premises in the event of inappropriate behavior and violation of any of the prohibitions listed in the house rules, without refunding the price of food and beverages if it has already been paid.
7. The operator reserves the right to expel a visitor from the premises if the visitor shows symptoms of a contagious disease, in particular symptoms of COVID-19.
8. The operator reserves the right to permanently or temporarily ban persons who repeatedly cause conflict situations on the premises.
9. The operator reserves the right to charge for damage to the premises' equipment (glass, porcelain, and other small items) at a flat rate of CZK 100 per item. In the event of damage, contamination, or destruction of property or equipment of higher value, the visitor is obliged to pay the full amount of the damage according to the extent of the damage (this also applies to board games).
10. The operator reserves the right to charge cleaning fees to visitors or institutions that use the premises outside of operating hours in the minimum amount of CZK 500, increased by the level of contamination or damage to the premises and/or property (see point 9).
11. The operator reserves the right to refuse entry to visitors who are inappropriately dressed (clothing that is dirty, torn, smelly, etc.), intoxicated, or under the influence of drugs or other addictive substances.
12. Smoking of tobacco products is prohibited in all indoor areas of the premises, with the exception of electronic cigarettes (which are only permitted in the main hall).
13. It is prohibited to bring and use pyrotechnics, explosives, and open flames on the premises.
14. It is prohibited to bring weapons of any kind onto the premises.
15. It is prohibited to bring drinks and food into the premises and consume them there, under penalty of a fine of CZK 500 and the possibility of expulsion of the visitor or institution and their members and guests from the premises.
16. The operator is not responsible for items left unattended on the premises, or for their loss, damage, or destruction.
17. It is not permitted to sell or serve alcoholic beverages, even in sealed packaging, to persons under the age of 18, persons who, in case of doubt, cannot prove with an ID card that they are over 18, persons who are intoxicated or under the influence of drugs, as well as offering, mediating, or otherwise enabling these persons to consume tobacco products.
18. The operator reserves the right to refuse entry to persons under the age of 18 at certain events announced in advance.
19. Visitors are required to observe the operating hours displayed on the entrance door to the premises. For safety reasons, visitors are allowed to enter the premises no later than 8:30 p.m. Upon prior agreement, it is possible to visit the premises outside of operating hours, but visitors are still required to follow the house rules.
20. The operator reserves the right to change the opening hours without prior notice.
21. Visitors are required to follow the instructions of the staff. Visitors are not allowed to borrow board games on display without prior consultation with the bar staff. Game rental fees are determined by the valid price list stated in the drinks menu.
22. Free-roaming animals are not allowed in the premises; animals on a leash are allowed. If any of the visitors present requests an animal to be removed from the premises or otherwise expresses their disagreement with its presence, the staff is entitled to banish the animal from the premises.
23. Parents or adult guardians are responsible for supervising children on the premises. If the behavior of children disrupts the peaceful atmosphere of the bar, the staff is entitled to banish the supervisors and children from the premises.
24. The operator reserves the right to change the house rules.
25. The wording of the house rules is displayed on a visible spot in the establishment and the current version is always available on the website <https://en.district5.cz/>. These house rules come into effect on the date of their announcement.
